### MEMORANDUM OF ASSOCIATION

of

### the ANTIGONISH WOMEN'S ASSOCIATION

- 1. The name of the Association is ANTICONISH WOMEN'S ASSOCIATION.
- 2. The objects of the Association are:
  - (1) To promote increased awareness and understanding of women's issues among women and the general public in the form of advocacy and information exchange.
  - (2) To develop a network of women throughout Antigonish Town and County.
  - (3) To establish a Women's Resource Centre and obtain permanent funding for same.
  - (4) To publish a Women's Newsletter.

PROVIDED that nothing herein contained shall permit the Association to carry on any trade, industry of business and the Association shall be carried on without purpose of gain to any of the members and that any surplus or any accretions of the Association shall be used solely for the purposes of the Society and the promotion of its objects.

PROVIDED, further, that if for any reason the operations of the Association are terminated or are wound up, or are dissolved and there remains, at that time, after satisfaction of all its devts and liabilities, any property whatsoever, the same shall be apid to some other charitable organization in Antigonish having objects similar to those of the Association.

- 3. The activities of the Association are to be carried on in the Province of Nova Scotia.
- 4. The registered office of the Association is at 222 Main Street,
  Antigonish, Nova Scotia, B2G 2C2.

We, the several persons whose names, addresses and occupations are subscribed, desire to be formed into a Society, in pursuance of this Memorandum of Association.
